

- 3. Eligibility Criteria: As per the Department of Posts Postman and Mail Guard (Group 'C' post) Recruitment Rules, 2018 notified in GSR 899 (E) dated 20.09.2018 read with Postman and Mail Guard (Group 'C' post) Recruitment (Amendment) Rules, 2020 notified in GSR 157 (E) dated 05.03.2020, the following categories of official(s) are eligible to appear in the examination:
 - (i) Multi Tasking Staff (MTS) in Level-I of the pay matrix with three (03) years regular service in the grade as on the 01.01.2020.
 - (ii) Gramin Dak Sevaks (GDSs) who have worked regularly for five (05) years in that capacity as on the **01.01.2020** and fulfilling the following conditions:
 - a) Educational Qualification: 10th standard pass from a recognized Board.
 - b) Age: Maximum age as on 01.01.2020 for UR candidates shall be 50 years, for SC/ST will be 55 and for OBC is 53.
 - c) The candidate should have studied local language (i.e. HINDI) at least upto 10th standard.
 - d) Knowledge of working on Computer.
 - e) The person appointed to the post of Postman shall have/acquire a driving license to drive two wheeler or three wheeler or light motor vehicle within a period of two years from the date of his appointment. However, persons with disability shall be exempted from the requirement of driving license. A candidate not having valid driving license at the time of appointment shall not earn periodical increment in pay till production of such license or for a period of five years from the date of appointment whichever is earlier and after production of such license or expiry of such five years period, pay shall be restored prospectively to the level pay would have reached had the periodical increment in pay was not withheld and no arrears of pay shall be paid for the intervening period. [This condition is required for recruitment to the cadre of Postman only]

Note:

- i) Candidate belonging to Postal Division shall clearly indicate order of preference in Application form for Postal Divisions excluding parent division followed by RMS divisions.
- ii) Candidate belonging to RMS division shall clearly indicate order of preference in Application form for RMS division excluding parent division followed by Postal divisions.
- iii) Candidate must exercise preference for all Recruiting Units for consideration in the proforma at Annexure-II. In case preference is exercised for a limited number of units and could not be allocated to one of those units as per merit vis a vis vacancy in the category he/she belongs to, he/she will not be considered for other recruiting units not preferred even though a candidate lower in rank to him/her is considered who has opted for that unit.
- iv) Order of preference (as per Annexure-II) once exercised shall not be changed.
- 4. <u>Pattern & Syllabus of Examination</u>: The examination will be conducted as per the revised pattern and syllabus circulated by Directorate vide letter No.17-08/2018-SPB-I dated 10.05.2019 under Annexure-'B' read with letter dated 10.06.2019, 20.06.2019, 26.06.2019, 28.06.2019, 11.07.2019, 23.07.2019, 11.12.2019 and letter No.17-08/2018-SPN-I-Part (I) dated 24.11.2020. All these instructions related to Pattern & Syllabus are enclosed.

Note:

- i) Paper-III i.e. 'Skill Test of Data Entry' will be conducted separately. Candidates who secure minimum qualifying marks in each paper(s) (Paper-I and Paper-II) will be shortlisted for Paper-III. Number of shortlisted candidates shall be 5 times of the number of vacancies.
- ii) The medium for 'Skill Test of Data Entry' will be ENGLISH only.
- iii) 'Skill Test of Data Entry' will be held on computer for 15 minutes only.
- iv) Evaluation of 'Skill Test of Data Entry' will be done by the online system.
- 5. <u>Centre of Examination</u>: The examination will be conducted at the Circle Headquarter only. The candidates will have to appear from their Divisions / Units to the examination centre at Circle Headquarter.
- 6. The application of the APS candidates should be sent to the concerned Divisions only and not to Circle Office.
- 7. This notification may be given wide publicity amongst all eligible candidates working in Divisions/Units.
- 8. This issues with the approval of Competent Authority.
