- 06 If any Disciplinary / Vigilance cases are pending / contemplated against the official the concerned Divisional Head should not relieve her and a report to be sent to this office immediately.

Before giving effect to the above transfers, a written declaration agreeing to the above conditions from the officials, in duplicate, should be obtained and kept on record in Service Books and personal files of the officials.
