

The above transfers are approved subject to the following conditions that:-

- a) The officials will not claim any composite transit grant, joining time etc for their transfer to the new division.
- b) The Seniority of the officials on transfer will determined in accordance with the provision under Rule-38 of Postal Manual Volume IV as amended from time to time.
- c) The officials will not claim repatriation/re-transfer to their parent unit until they are eligible to do so, as per instructions contained in Para 3A(vi) of the Directorate letter dated 17-01-2019.
- d) If any disciplinary / vigilance case is pending / contemplated against the officials, he/she should not be relieved and action may be taken as per instructions contained in Para 3C(xv) of the Directorate letter No. 141-141/2013-SPB-II dated 17-01-2019.
- e) In the case of probation period is extended before the official is relieved, the official shall not be transferred even after issue of transfer orders.
- f) He/She may be relieved only after receipt of posting order from the concerned unit.

Before giving effect to the transfer order, written declaration agreeing to the above conditions of transfer should be obtained from the officials & kept in his Service Book.
