
The aforesaid transfers are approved under provisions of Rule 38 of Postal Manual Vol IV as amended from time to time subject to following terms and conditions:-

- That they will not claim any TA/TP/Composite Transfer Grant etc.
- That they will have to forgo all claims for confirmation in the old Unit if not confirmed.
- That the seniority of the officials on joining duty in the new Units will be fixed in accordance with the provisions of Rule.38 of Postal Man. Vol.IV as amended from time to time.
- That they will not claim repatriation to their parent Unit.
- The relieving and reporting units will ensure that the official ordered to be relieved on the scheduled date as decided by this office mentioned above in respective column, if not so, reasons to be recorded in writing.

- vi). The officials may not be relieved, if any disciplinary/vigilance case is pending /contemplated against them and action may be taken as per instructions in per Para 3 C (xv) of Directorate letter dated 17.01.2019.
- vii). The terms and condition in Directorate's transfer policy circulated vide 141-141/2013-SPB-II dated 17.01.2019 and others will hold good.
3. Before giving effect to the transfer orders, written declarations agreeing to the conditions of transfer detailed above should be obtained from the official and kept in his service book.

Charge report and Compliance should be submitted to all concerned after doing needful.
