- 05 That the official will have to forego all claims of confirmation in their parent unit.
- 06 If any Disciplinary / Vigilance cases are pending / contemplated against the official the concerned Divisional Head should not relieve her and a report to be sent to this office immediately.

Before giving effect to the above transfers, a written declaration agreeing to the above conditions may please be obtained from the official in duplicate and kept on record in Service Book and personal files of the officials.
