Kindly refer to your Circle Office letter no. Estt/10-1/2016-20 dated 17.08.2021 on the subject cited above.


2. The proposal for creation of a new Karad Postal Division by bifurcation of existing Satara Division has been examined in detail in consultation with Integrated Finance Wing (IFW) of the Directorate. **The proposal has been approved by the Competent Authority subject to the following conditions:**

- a) To ensure that there will be increase in the revenue due to this bifurcation and creation of new Division.
- b) Non-recurring and recurring expenditure on account of the creation of Division will be limited to the extreme necessities.
- c) There will be review of financial performance of both Satara Division as well as Karad Division after completion of one year.

3. In view of the above, the Circle is requested to take further necessary action accordingly and furnish an Action Taken Report to this office. The review after completion of one year is a mandatory condition of IFW, therefore, the same may be strictly adhered to.
