Subject: Limited Departmental Competitive Examination (LDCE) from MTS cadre and Competitive Examination for GDS cadre for vacancy year 2021 for recruitment to the cadre of Postman/Mail Guard held on 09.01.2022(Sunday) and DEST on 09.04.2022(Saturday) of Bihar Circle- Declaration of surplus result.

In pursuance of Directorate letter no. A-34012/07/2021-DE dated 28.09.2021 and Circle Office, Patna letter no. R&E-83/PM-MG/Exam/2021 dated 30.11.2021, the notification for LDCE for promotion to the cadre of Postman/Mail Guard from eligible MTS & GDS were issued on 30.11.2021. In the said notification it was announced to conduct the above examination for the vacancy year 2021 on 09.01.2022. Accordingly examination of Paper – I & II were conducted on 09.01.2022 and Data Entry Skill Test (DEST) Paper – III on 09.04.2022.

Now, the results were prepared as per guidelines of Directorate issued vide letter no. 04-08/2019-SPN-I dated 26.07.2019 & 06.09.2019, letter no. 17-08/2018-SPN-I-Part (I) dated 24.11.2020 and letter no. 17-08/2018-SPB-I dated 20.06.2019 & 10.05.2019.

- 2. On successful completion of aforesaid examination, provisional answer keys of Paper 1 & II (in series A,B,C & D in both papers) inviting feedback/challenges from candidates were uploaded on indiapost website on 11.01.2022. And based on responses received from candidates, answer keys for Paper I & II have been finalized and circulated on 11.03.2022.
- 3. In pursuance of Annexure B to Directorate letter no. 17-08/2018-SPB-I dated 10.05.2019 read with letter dated 26.06.2019 selection has been made strictly on merit based on marks secured on Paper I only. Paper II in Regional Language is considered as qualifying and the score in Paper II has not been taken into account for assessment of merit and following are the qualifying criteria for each paper of MTS & GDS to Postman/Mail Guard Examination:-

Instructions

- 1. In case, it is subsequently found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reason or in case any mistake is found with regard to announcement of result of any candidate or any reason for whatsoever, his/her name will be deleted from the list of successful candidates, as the same may be. This should be incorporated in the promotion/appointment letters issued.
- 2. The selection has been made based on merit in the examination vis-à-vis date of birth has been made as next criterion in case of equal marks of two or more candidates and the other candidate has been given preference over the younger candidate as per instructions of Directorate issued vide letter no. 04-08/2019-SPN-I dated 11.12.2020.
- 3. If any disciplinary/vigilance case is pending against the candidate, the prescribed instructions of the department may be followed before effecting promotion under intimation to this office. Divisional Heads/Unit Heads must ensure that officials are not undergoing any punishment or any disciplinary case is pending.
- 4. Provisional candidate: The Unit/Divisional Heads are requested to immediately finalize the candidature of provisional candidates so that they may not have to wait for the result inordinately. It may be ensured that no provisional candidate is found in the list of selected candidates and if found in the list of selected candidates, they should not be given promotion/appointment under any circumstances without regularization of candidature and the same may be brought to the notice of Circle Office, Patna.
- 5. It is informed that the name of the candidates have been arranged in the order of merit and their allotment to the Division/Unit as per order of preference in accordance with Directorate guidelines issued vide letter no. 02-01/2018-SPB-I dated 07.02.2019.
- 6. The names of candidates against the Roll No. concerned has been shown as furnished by the Divisional/Unit Heads. If, however, any mistakes in the Name/Roll No./Community of any candidate are noticed, the same may be corrected under intimation to this office.
- 7. The selected candidates should assume the charge at new place of posting within 30 days after issue of this letter. In case they do not want to go on promotion they will submit their refusal within 15 days from the issue of this letter. Concerned Divisional heads will issue their place of posting within a week from issue of this letter after observing all the formalities of appointment.
- 8. If any discrepancies/irregularities/omissions found in name, Roll No., Marks, Community etc. at stage against any candidate, the result of the said candidate to be cancelled.
