Above mentioned transfers are subject to the conditions noted below:-

1. That the seniority of the officials on joining duty in new unit will be determined in accordance with the provisions of Rule-38 of Postal Man.Vol. IV as amended from time to time.
2. That they will not claim any TA/IP.

3. That they will not claim repatriation to their parent unit until they are eligible to do so.
4. That they will have to forgo all claims for confirmation in the old unit even if a permanent vacancy was available because of a retrospective permanency of posts or for any other reason for which they were entitled to confirmation in their old unit.
5. That after transfer to new unit they will be eligible for confirmation in the new unit only according to their position in the gradation list of the new unit.
6. The official may not be relieved, if any disciplinary/vigilance case is pending/ contemplated against them.
