5. That the officials will forego all claims for confirmation in the parent unit.
6. That the officials should not be relieved, if any disciplinary /vigilance cases are pending /contemplated and a report to be sent to this office immediately.

Before giving effect to the transfer order, a written declaration agreeing to the conditions of transfer detailed above, should be obtained from the official and be kept in the Service Book and PF of the official.
