- 3- That the official will not claim for repatriation to the parent unit/Division.
- 4- That the official will have to forgo all claims for confirmation in the old unit even if permanent vacancy was available because of retrospective permanency of post or for any other reason for which he/she was entitled to confirmation in his old unit.
- 5- That after transfer to new unit, the official will be eligible for confirmation in the new unit.
- 6- That the official will be adjusted in respective community and quota of vacancies in which he/she was recruited.
- 7- The official may not be relieved, if any disciplinary/vigilance case is pending /contemplated against the official.
- 8- The official may be relieved on receipt of posting order.
- 9- The terms and conditions as laid down in Directorate's transfer policy circulated vide F.No. 141-141/2013-SPB-II dated 17.01.2019 as amended from time to time will hold good.
- 10-Relieving of official will depend on actual working conditions of Division.

The concerned authorities may issue necessary posting orders. The official may be relieved only after receipt of posting order.
