- 3. I am directed by the Competent Authority that the following should be ensured before the appointment is issued:-
  - (a) That the Divisional Head and the appointing authority should satisfy themselves about the fulfillment of eligibility condition of age, qualification etc. as mentioned in GDS Recruitment Rules and further to obtain the documents requisitioned at column (j) under the table at 2 (a) above (if any).
  - (b) The Divisional Head should obtain and verify the needed information for which the case is deferred as at column (j) under the table at 2 (b) above. Further, they will ensure that, all cases submitted to the CO are complete in all respect and the rules on the subject are fulfilled in every case.
  - (c) That in respect of cases not approved /rejected by the CCE as at para 2 (c), the applicants should be informed of the same with the reasons for rejection through Registered AD and acknowledgement be kept on records.

- (d) That the age, community and educational qualification certificates have been got verified and attested by the ASPOs/ IPOs.
- (e) That the review as prescribed is carried out to fill up the vacancy and the approval of Head of Circle is obtained from Establishment Section of Circle Office in terms of Postal Directorate Letter No.17-103/2007-GDS dated 14/07/2009.
- (f) That all pre-appointment formalities such as obtaining PVRs, Declarations, descriptive particulars, Oath of allegiance, Health Certificate etc. should be completed before issuing appointment by the appointing authority.
- (g) That while issuing appointment letters Appointing Authority is to obtain undertaking in writing from selected candidates that they will maintain the family/dependents of the deceased GDS and that in case it is proved (at any time) that the family members are being neglected or are not being maintained properly by him/her, the engagement may be terminated forthwith. Such undertaking be kept in record.
- (h) That the dates of appointment of the candidates as well as date of joining may be intimated to this Office promptly.
