Subject: Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postman and Mail Guard from eligible Multi- Tasking Staff for the vacancy year 2022, held on 04.09.2022 (Sunday) and DEST on 19.12.2022 (Monday) of Bihar Circle- **Publicition of Division wise list of successful MTS candidates (Merit list) out of the qualified MTS candidates of recruiting Division.**

In pursuance of Postal Directorate, New Delhi letter no. A-34012/06/2022-DE dated 08.07.2022 and Circle Office, Patna letter no. R&E-83/PM-MG/MTS/Exam/2022 dated 15.07.2022, the notification for LDCE for promotion to the cadre of Postman/Mail Guard from eligible MTS was issued on 15.07.2022. In the said notification it was announced to conduct the above examination for the vacancy year 2022 on 04.09.2022 (Sunday). Accordingly examination of Paper – I, II & III were conducted on 04.09.2022 (Sunday) and Data Entry Skill Test (DEST) Paper – IV on 19.12.2022 (Monday).

Now, the results has been prepared as per guidelines of Postal Directorate issued vide letter no.17-08/2018-SPN-I dated 05.04.2022 circulated vide this office email dated 06.04.2022 (06.06 PM), 17-08/2018-SPN_I dated 15.06.2022 circulated vide this office letter No. R&E-83/Rlg/2014 dated 22.06.2022. Postal Directorate letter No. 03-03/2019-SPN-I (Pt-I) dated 17.05.2022 and 04.08.2022.

2. On successful completion of aforesaid examination, provisional answer keys of Paper – I, II & III (MCQ in series A,B,C & D of three papers) inviting feedback/challenges from candidates were uploaded on indiapost website on 08.09.2022. On receipt of responses from candidates and recommendation of moderation committee (2) two question in Ppaer-I have been deleted. Due to deletion of two questions in Paper-I, minimums qualifying marks have been reduced as per para No. 17 of SOP circulated vide Postal Directorate letter No. A-34012/02/2022-DE dated 11.08.2022 and communicated to all concerned vide this office letter No. R&E/SOP/2022 dated 16.08.2022 and based on responses received from candidates, answer keys for paper – I, II & III have been finalized. The same were uploaded on India Post Website on 25.10.2022 and 09.11.2022
3. In pursuance of Postal Directorate, New Delhi letter No 17-08/2018-SPN-I dated 05.04.2022, slection a candidate has been made strictly on merit based on marks secured in Paper I and Paper II (Combined i.e total of marks secured in Paper I and Paper II) who has also secured minimum qualifying marks in Paper III (Local Language) and Paper-IV (DEST).



Instructions

- In case, it is subsequently found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reason or in case any mistake is found with regard to announcement of result of any candidate or any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the same may be. This should be incorporated in the promotion/appointment letters issued.
- The selection has been made based on merit in the examination and instructions contained in Postal Directorate letter no. 04-08/2019-SPN-I dated 11.12.2020 for promotion of Departmental examination.
- If any disciplinary/vigilance case is pending against the candidate, the prescribed instructions of the department may be followed before effecting promotion under intimation to this office. Divisional Heads/Unit Heads must ensure that officials are not undergoing any punishment or any disciplinary case is pending.
- Provisional candidate: The Unit/Divisional Heads are requested to immediately finalize the candidature of provisional candidates so that they may not have to wait for the result inordinately. It may be ensured that no provisional candidate is found in the list of selected candidates and if found in the list of selected candidates, they should not be given promotion/appointment under any circumstances without regularization of candidature and the same may be brought to the notice of Circle Office, Patna.
