(ii) <u>Transfer cases</u>: Incumbency position of an officer, who is transferred to a Circle but not joined therein, should be shown against that allotted Circle only. The respective allotted Circle in this regard may indicate the details of such officers.

- (iii) <u>Promotion cases</u>: Incumbency position of an officer, who is transferred/allotted on promotion to a Circle but not assume charge of the promoted post, should be shown against that allotted Circle only. The respective allotted Circle in this regard shall indicate the remarks "Not yet joined" in respect of such officers against the column of "Date of Joining in the PS Gr. cadre."
