2. The details of Division-wise vacancies remained unfilled due to declinations and unfilled EWS vacancies diverted to other category as per DoPT OM No. 36039/1/2019-Estt.(Res.) dated 31-12-2019 & OM No. 43011/11/2022-Estt. 


