Madam/Sir,

All India Draft Seniority List of Inspector Posts Cadre for the year 2010 has been uploaded on India Post official website. Draft All India Seniority List was attempted on the basis of records provided by Departmental Examination Section of the Department, all Circles and was uploaded on the Department's website vide communication No. No. X-07/10/2020-SPN-II dated 09th December, 2020 for comments of all stakeholders. Draft seniority list was prepared in the following manner:

- (a) The name of the Direct Recruit candidates in order of merit obtained by them in CGLE -2010 conducted by SSC
 - (b) Personnel serving in Army Postal Service have been placed en-bloc below the officials at (a) above on the basis of information furnished by the Circle concerned, if any.
2. All Circles were requested to circulate the All India Draft Seniority List of Inspector Posts cadre for the year 2010 among all the officials and inform this Directorate about any factual inaccuracy/ discrepancy therein. On receipt of such information from Circles, **names of 82 Inspector Posts have been deleted.**
3. **After deletion of these 82 records**, an All India Final Provisional *Inter-se* Seniority List 2010 has been prepared. Further, there was no Departmental Examination for the vacancy year 2010 held by the Department. There is no possibility of placing qualified status APS officials in the year 2010.


