- 5. The Divisional Heads may ensure that provisional appointment orders are issued to the candidates within 03 days. While issuing the appointment order, the term "APPOINTMENT" only to be used. The term "PROMOTION" Should NOT be used any-where in respect of these GDS candidates.
- 6. If any candidate is unwilling to accept appointment he/she should submit two Original Copies of unwillingness to the head of parent Division. The Divisional Head will retain one copy and send the second original copy of unwillingness along with attestation to the concerned ROs by 09-02-23 and the Regional Office will further submit the same so as to reach this office by 10-02-2023.
- 7. All other terms and conditions issued vide this office memo No. R&E/1-7/2022 dated 25-11-2022 & memo No. R&E/1-7/2022/II dated 13-12-2022 and 19-12-2022 holds good. The contents of this memo may be brought to the notice of all the candidates.
