4. In case, at any-time, if it is detected that the candidate so selected had applied and appeared the examination with false declaration relating to educational qualification, category, length of service and physical disability etc., his/her selection will be cancelled without any notice.

If it is later noticed that the permission granted to any candidate to appear for the examination was not valid due to one or the other reasons, as per the orders on the subject, the candidature will be cancelled without any notice and his/her name will be removed from the list of successful candidates at any stage.

6. The appointing authorities are requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time to time on the subject as GDS are outside the civil service. Also, the Divisional/Unit Heads are requested to re-check the pre-requisite conditions prescribed for candidates, with reference to their recommendations while forwarding the applicant forms.

7. Before appointment, it should be ensured that, no disciplinary/vigilance case is pending or contemplated or punishment is current against the selected/allotted candidates. If any, suitable action may be taken and such case should be referred to this office immediately through proper channel.
