**Subject: All India Seniority list of Inspector Posts for the year 2007.**

Madam/Sir,

I am directed to refer to this Department's letter of even no. dated 18<sup>th</sup> January 2023 *vide* which All India Final Provisional Seniority List of Inspector Posts for the year 2007 was issued.

2. On the basis of input received from the Circles, following rectification has been done in All India Seniority List of Inspector Posts, 2007 (AISL 2007)
  - i. The name of Shri Pradeep Kumar Sharma [SL no. 114] has been added in Seniority List 2007.
  - ii. The name of Shri Narendra Kumar (SI no 103 of earlier Seniority List referred above) has been deleted as his name is already listed in AISL 2006.
  - iii. Shri Arun Kumar Tiwari was initially selected under relaxed standard available to APS. Later on, he was selected under meritorious standards in LDCE 2007. Therefore, his name has been deleted from the APS candidate list and placed at SI No. 174 under meritorious standards in LDCE 2007 according to his total marks (282).
  - iv. The Name of following nine officials have <sup>been</sup> included in the APS list:



3. The candidates serving in APS and declared qualified in IP Examination under concession available for APS personnel, have been interpolated according to date of completion of 3 years of JCO. In case, date of completion of 3 years of JCO is same for two or more officials, marks obtained by them will be the criteria.
4. Accordingly, Revised All India Seniority List of Inspector Posts, 2007 is enclosed herewith in supersession of earlier list circulated vide letter dated 18<sup>th</sup> January 2023.
5. The Revised All India Seniority List of Inspector Posts, 2007 is subject to the final outcome of following Litigations:
- O.A. No. 296/2019 filed by Manish Kumar Srivastava & Ors. Vs. UOI in Principal Bench, Hon'ble CAT, Delhi against the Final All India Combined Seniority List of Inspector Posts for the years 2001/2002. The applicants are direct recruits selected through Combined Graduate Level Examination – 2003 conducted by Staff Selection Commission.
  - O.A. No. 180/985/2018 titled G. Jayasree Vs UOI, filed by departmental promotees at Hon'ble Tribunal, Ernakulam Bench, Kerala [now tagged with O.A. 296/2019, CAT, PB, New Delhi] aggrieved by the decision of revision of seniority list of the cadre of Inspector Posts. CAT, Ernakulam Bench has stayed the said revision of seniority list.
  - Any other litigation pending before competent court as on date, against the Seniority List of IP cadre.
