
I am directed to refer to this Department's letter of even no. dated 20<sup>th</sup> January 2023 *vide* which All India Final Seniority List of Inspector Posts for the year 2003 was issued.

2. On the basis of input received from the Circles, following rectifications have been done in All India Seniority List of Inspector Posts, 2003 (AISL, 2003)

- i. The name of Ms Aparna Sandiyal [Rank 84] has been interpolated at Sl No 156 as her name was left out from the AISL 2003
- ii. The Seniority of Shri Anoop Agarwal has been refixed at Sl No 299 from Sl no 345 as per result issued vide DE letter no 34013/3/2003-DE dated 28.07.2004.
- iii. Previously, total marks of Shri N K Dubey at Sl No. 344 was not available, which has now been communicated by the Circle. Accordingly, his name has been placed at Sl No 304 with respect to his total marks (284).

UOI in Principal Bench, Hon'ble CAT, Delhi against the Final All India Combined Seniority List of Inspector Posts for the years 2001/2002. The applicants are direct recruits selected through Combined Graduate Level Examination – 2003 conducted by Staff Selection Commission.
- ii. O.A. No. 180/985/2018 titled G. Jayasree Vs UOI, filed by departmental promotees at Hon'ble Tribunal, Ernakulam Bench, Kerala [now tagged with O.A. 296/2019, CAT, PB, New Delhi] aggrieved by the decision of revision of seniority list of the cadre of Inspector Posts. CAT, Ernakulam Bench has stayed the said revision of seniority list.
- iii. Any other litigation pending at competent court as on date, against Seniority List of IP cadre


