I am directed to refer to this Department's letter of even no. dated 13th February, 2023 vide which All India Seniority List of Inspector Posts for the year 2012 was issued.

2. On the basis of inputs received from the Circles, following rectifications have been done in All India Seniority List of Inspector Posts, 2012 (AISL, 2012):

- i. Date of entry in IP Cadre in respect of Shri Jatinder Kapoor has been changed to 18.06.2013 from 17.06.2013.
- ii. Date of entry in IP Cadre in respect of Ms Anju Bala has been changed to 17.06.2013 from 17.06.2004.
- iii. Name of Shri Niladri Basak has been corrected from Nilandri Basak.
- iv. Name of Shri Munna Lal Sharma has been added in APS list at Sl no 265 as per JCO completion date (24.01.2013).

3. The candidates serving in APS and declared qualified in IP Examination under concession available for APS personnel, have been interpolated according to date of completion of 3 years of JCO. In case, date of completion of 3 years of JCO is same for two or more officials, marks obtained by them will be the criteria.

4. Accordingly, Revised All India Seniority List of Inspector Posts for the year 2012 is enclosed herewith in suppression of earlier list circulated vide letter dated 13th February, 2023.

5. The Revised All India Seniority List of Inspector Posts, 2012 is subject to the final outcome of following litigations:


(i). O.A. No. 296/2019 filed by Manish Kumar Srivastava & Ors. Vs. UOI in Principal Bench, Hon'ble CAT, Delhi against the Final All India Combined Seniority List of Inspector Posts for the years 2001/2002. The applicants are direct recruits selected through Combined Graduate Level Examination – 2003 conducted by Staff Selection Commission.

(ii). O.A. No. 180/985/2018 titled G. Jayasree Vs. UOI, filed by departmental promotees at Hon'ble Tribunal, Ernakulam Bench, Kerala (now tagged with O.A. 296/2019, CAT, PB, New Delhi) aggrieved by the decision of revision of seniority list of the cadre of Inspector Posts. CAT, Ernakulam Bench has stayed the said revision of seniority list.

(iii). Any other litigation pending before competent court as on date, against the Seniority Lists of IP cadre.
