The Limited Departmental Competitive Examination/Competitive Examination for recruitment to the cadre of Postal Assistant/Sorting Assistant/Postal Assistant (Circle Office) from eligible Postman/Mail Guard, MTS and GDS for the vacancy year 2023 was held on 12.03.2023 (Paper-I & II) and 14.05.2023 (Paper-III i.e. Data Entry Skill Test). 2. 15 ST backlog vacancies remained unfilled due to non availability of eligible candidates in respective category. Divisional Head concerned are requested to take action against these vacancies as per the instructions on the subject.

2.1 There are 2 vacancies reserved for PwBDs. Since, the decision in Case No - 13832/1021/2023/189475 is awaited from Court of Chief Commissioner for Persons with Disabilities (Divyangjan), the result against these vacancies will be declared in due course.

3. The names of the candidates have been arranged in the order of merit. If however, there is any mistake in the name/Roll Number/community of the candidate is noticed the same may be corrected and intimated to this office immediately. The candidates who obtained same marks, Divisional Heads are requested to decide their seniority at their end as per the instructions.

4. Before issuance of appointment orders to the selected candidates, all Divisional Heads should match the photograph of the candidate allowed to appear in the examination with the videography clips recorded during the examination. CD/DVD of Paper-I & II containing videography of said examination will be supplied to all the Divisional Heads by SPOs Ambala.

5. The Divisional Heads before promotion of the official should ensure that no vigilance/disciplinary case is either pending or contemplated against him/her and no punishment like stoppage of increment is current against the official. In case there is any such case, the official concerned may not be promoted and the facts be reported to this office immediately.

The eligibility of the candidates to take the examination has been decided on the basis of the information furnished by the Divisional Heads while forwarding their applications for this examination. If it is later on found that any of the selected candidate was not eligible to take the examination under the existing rules or instructions on the subject or for any other reason whatsoever, his/her name will be deleted from the list of successful candidates or list of candidates securing concession as the case may be. The result is also subject to change due to re-totalling and verification of answer books in accordance with the instructions in this regard.

7. In case, any candidate is not willing for promotion to the cadre of PA/SA, then his unwillingness duly signed by him/her, verified and countersigned by the Divisional Head should be submitted to this office by **29.05.2023**.
