I am directed to refer to this Department's letter of even no. dated 24th February, 2023 vide which All India Seniority List of Inspector Posts for the year 2015 was issued.

2. On the basis of inputs received from the Circles, following rectifications have been done in All India Seniority List of Inspector Posts, 2015 (AISL, 2015):

i. Name of Ms. Geeta Karmakar has been included at Sl No. 207 of AISL, 2015.

ii. Date of appointment in IP cadre of Sh. Koushal Kulkarni has been corrected as 15.09.2017 instead of 16.09.2017.

iii. Marks scored by Sh. Praveen Kumar have been corrected from 588 to 594 placed at Sl No. 316 of AISL, 2015.

iv. Name of Sh. Pijush Kanti Bhattacharjee has been added in AISL, 2015 at Sl No. 323 as 3 years of JCO has completed on 06.06.2019.

v. Date of appointment in IP cadre of Sh. Amit Kumar Pandey has been corrected as 30.10.2017 instead of 08.06.2018.

vi. Seniority position of Sh. Ravinder Singh has been changed from Sl No. 61 to Sl No. 58 as per date of appointment in feeder cadre (Sl No. 61 as per earlier Seniority List referred above).

vii. Seniority position of Sh. Pradeep Kumar Mishra has been changed from Sl No. 43 to Sl No. 65 as per date of appointment in feeder cadre (Sl No. 43 as per earlier Seniority List referred above).

3. The candidates serving in APS and declared qualified in IP Examination under concession available for APS personnel, have been interpolated according to date of completion of 3 years of JCO. In case, date of completion of 3 years of JCO is same for two or more officials, marks obtained by them will be the criteria.

4. Accordingly, Revised All India Seniority List of Inspector Posts for the year 2015 is enclosed herewith in suppression of earlier list circulated vide letter dated 24th February, 2023.

5. The Revised All India Seniority List of Inspector Posts, 2015 is subject to the final outcome of following litigations:

(i). O.A. No. 296/2019 filed by Manish Kumar Srivastava & Ors. Vs. UOI in Principal Bench, Hon'ble CAT, Delhi against the Final All India Combined Seniority List of Inspector Posts for the years 2001/2002. The applicants are direct recruits selected through Combined Graduate Level Examination – 2003 conducted by Staff Selection Commission.

(ii). O.A. No. 180/985/2018 titled G. Jayasree Vs. UOI, filed by departmental promotees at Hon'ble Tribunal, Ernakulam Bench, Kerala (now tagged with O.A. 296/2019, CAT, PB, New Delhi) aggrieved by the decision of revision of seniority list of the cadre of Inspector Posts. CAT, Ernakulam Bench has stayed the said revision of seniority list.

(iii). Any other litigation pending before competent court as on date, against the Seniority Lists of IP cadre.
