- 5. The conditions prescribed in Directorate's F No.W-17/10/2023-SPN-I-DOP dated 06-03-2023 is applicable to all the candidates declared successful for promotion through LDCE to PA/SA Cadre for vacancy year 2023 issued vide this office memo of even no. dated 23-05-2023 and memo no. ibid.
- 6. The successful candidates may be directed to accept / decline their place of posting on promotion by 07th June 2023, failing which their promotion will be deemed to be declined.
- 7. All the Heads of units of selected candidates should be instructed to take necessary action for joining of newly selected candidates as per extant provisions. The Divisional/Unit heads are requested not to send separate letter of carrying out joining process/appointment letters to Circle Office. The joining process to be completed on or before 09-06-2023. A consolidated report to be submitted to this office by Regional Offices on 12-06-2023.
- 8. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules. It may be <u>ensured that no provisional candidate is given appointment without regularization of their</u>

The official/candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office as per Directorate's letter no.
