Subject: Limited Departmental Competitive Exam (LDCE) from eligible official for promotion to the posts of PA (CO/RO), PA (SBCO & ICO), PA (Post office) and SA (RMS) and Competitive Examination for recruitment to the cadre of PA/SA from GDSs for unfilled LDCE Vacancy of PA/SA for the vacancy year 2023 Exam held on 12.03.2023 and DEST held on 25.06.2023 (Sunday). – **Declaration of result of Bihar Circle.**

In pursuance of Postal Directorate letter no. A-34012/01/2023-DE Dated 18.01.2023 and Circle Office Patna letter no. R&E-52/LGO Exam/2023 dated 23.01.2023 and R&E-52/LGO Exam/2022(GDS) Dated 23.01.2023 the notification for LDCE for promotion to the cadre of PA/SA from eligible Postman/Mail guard/MTS & GDS was issued.the Examination of Paper-I & II were conducted on 12.03.2023(Sunday) and Paper-III (DEST) on 25.06.2023(Sunday).

Now, the results has been prepared as per guidelines issued by Postal Directorate, New Delhi letter no. 17-08/2018-SPB-I dated 10.05.2019 & 20.06.2019, letter no. 04-08/2019-SPN-I dated 11.12.2020, letter no. X-12/6/2021-SPN-II dated 31.12.2021, letter no. 17-08/2018-SPN-I dated 22.07.2022 and X-7/6/2022-SPN-II dated 12.04.2022.

2. On successful completion of aforesaid examination, provisional answer keys (MCQ) for Paper-I & II (in series A, B, C & D in both papers) inviting feedback/challenges from candidates were uploaded on Indiapost website on 15.03.2023. Based on responses received from candidates, answer keys for Paper-I & II were finalized and uploaded on Indiapost website on 31.05.2023. The list of candidates who have qualified in Paper-I & II was prepared for LGO candidates and uploaded on Indiapost website on 17.06.2023 with reference to the Postal Directorate Letter no. 17-08/2018-SPN-I dated 19.12.2022..

3. In pursuance of Annexure - C of Postal Directorate letter No. 17-08/2018-SPB-I dated 10.05.2019 read with letter no. ibid dated 26.06.2019 selection has been made strictly based on merit in accordance with marks secured on Paper-I only. Paper-II in Regional Language is considered as qualifying and the score in Paper-II has not been taken into account for assessment of merit.

On receipt of responses received from the candidates and recommendation of Moderation Committee three questions in Paper-I have been deleted. Due to deletion of three questions in Paper-I, minimum qualifying marks have been reduced as per para no. 17 of SOP circulated vide Postal

6. The Staff Section of Circle Office Patna vide letter no. Staff/Cadre Management/PA/SA/2023 dated 04.05.2023 have communicated the vacancy position for above LDCE unit wise and category wise. And four backlog PH vacancies were also included for the declaration of result.

10. INSTRUCTIONS

- In case, it is subsequently found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reason or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This fact should be incorporated in the promotion/ appointment letters issued.
- In case of Departmental employees selection has made as per direction mentioned in para 2(A) of Postal Directorate letter no. 04-08/2019-SPN-I dated 11.12.2020.

- iii. If any disciplinary/vigilance case is pending against any of the candidate, the prescribed instructions of the department may be followed before effecting promotion under intimation to this office. Divisional Heads/Unit Heads must ensure that officials are not undergoing any punishment or any disciplinary case is pending.
- iv. Provisional Candidate: The Unit/Divisional Heads are requested to immediately finalize the candidature of provisional candidates so that they may not have to wait for the result inordinately. It may be ensured that no provisional candidate is found in the list of selected candidates and if found in the list of selected candidates, they should not be given promotion/appointment under any circumstances without finalization of candidature and the same may be brought to the notice of Circle Office, Patna.
- v. It is informed that the name of the candidates have been arranged in order of merit and their allotment to the Division/Unit as per order of preference in accordance with Directorate guidelines issued vide letter no. N-12/6/2021-SPN-II dated 31.12.2021.
- vi. In respect of SC/ST/PH candidates, "promotion of the candidates is provisional subject to verification of their status. Head of the Unit will take an undertaking from the officials to this effect at the time of their relieving and ensure verification of caste/PH status within one month".
- vii. As per Directorate letter no. W-04/2/2020-SPN-I-Part(I) Dated 19 October, 2020 Postman/MTS/GDS selected for appointment to the posts of PA/SA, whether through competitive examination or seniority, shall be appointed straightway after completing pre-appointment formalities without waiting for completion of prescribed institutional induction training.

The Divisional/Unit Heads will take further necessary action for circulation of the content of this communication to all concerned and ensure completion of appointment process within 15 days.


