Declaration of Surplus results in respect of Competitive Examination for recruitment to the cadre of Postman/Mail Guard for the vacancy year 2023 (01-01-2023 to 31-12-2023) held on 30-04-2023 and DEST–Paper-IV held on 25-06-2023.

This is in continuation of this office memos of even number dated 07-07-2023, 26-07-2023, 28-08-2023 and 05-09-2023. The Competent Authority is now pleased to announce the surplus results of Competitive Examination for recruitment to the cadre of Postman from eligible GDS candidates of other recruiting Divisions/Units of the Circle for the unfilled vacancies reported by Regions earmarked for GDS quota and unfilled vacancies of LDCE for Postman/Mail Guard transferred to GDS quota. Accordingly, names of Circle meritorious candidates declared successful for appointment to the cadre of Postman/Mail Guard in respect of other Recruiting Division / Unit from eligible qualified GDS is enclosed as **Annexure-I**. The allotment is done based on the Circle merit i.e marks secured in Paper-I&II, options/preferences submitted by the candidates, their category and to the extent of vacancies available on their turn of allotment.

- 2. The details of unfilled vacancies to be offered to the qualified meritorious candidates of other Recruiting Division/Units of the Circle is enclosed as **Annexure-II**. In respect of PwBD vacancies of the vacancy year 2022, has been filled up by other than a person with benchmark disability due to non-availability of qualified PwBD candidates as per the instructions issued by Postal Directorate vide letter No.12-4/2017/SCT dated 07-02-2018.
- **3.** In cases where preference is exercised for limited number of Divisions/units and could not be allocated to one of those limited Division/Units as per merit vis-à-vis vacancy in the category he / she belongs to has not been considered for Division/Units not preferred by him/her, even though a candidate lower in rank to him / her has been considered who has opted for that Division/Unit.
- 4. These candidates will be governed on Rule-38 transfers and repatriations as per the rules on the subject.
- 5. Regions are requested to verify the relevant particulars of the selected candidate(s) at their own level. In case, it is subsequently found that any of the qualified candidate (s) was not eligible to take the examination under the extant rules or instructions on the subject for any other reasons or in case any mistake is found with regard to list of qualified candidates for any reason whatsoever, the action taken may be brought to the notice of Circle Office.
- 6. The information relating to vacancies, name(s) of the candidate(s), their roll number(s) and category (ies) etc., have been shown on the basis of information furnished by the Region/Division/Units. In case there are any mistakes in the details of vacancies, candidate(s) etc., the same may be intimated to this office for necessary action. If however, there is any mistake in the Name / Roll No. / Category of the candidate(s) is noticed, the same may be corrected and intimated to this office immediately.
- 7. In case, if it is found subsequently that any of the promoted/selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidate's due to any unforeseen reason in

# 1/79621/202 accordance with the existing rules and instructions on the subject or orders of Hon'ble CAT/High Court, if any."

- **8.** Before appointment, it should be ensured that, no disciplinary/vigilance case is pending or contemplated or punishment is current against the selected/allotted candidates. If any candidate mentioned in these results have been proceeded with disciplinary/vigilance case, the same should be treated as deemed sealed cover by the RO/DO as the case may be and intimated to this office.
- **9.** It may be ensured that no provisionally permitted candidate is given appointment without regularization of his/her candidature. The divisions/units are requested to verify the current status of the these candidate(s) before appointment.
- **10.** If the name of any provisionally recommended and not recommended candidate is found in the selection list, the same may be immediately brought to the notice of this office for immediate necessary action.
- **11.** The selection of the candidates is purely provisional subject to the fulfilment of required conditions of relevant Recruitment Rules & verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit.
- 12. The Divisional/Unit Heads, before giving appointment to the selected candidates should ensure that the selected candidates fulfil all required conditions of relevant Recruitment Rules of Postman /Mail Guard. The appointing authorities are requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time to time on the subject.
- 13. The Divisional /Unit Heads are requested to issue Appointment orders to the successful candidates IMMEDIATELY clearly indicating that if the official does not join within three (03) days it will be deemed to have been declined. Official on leave may be allowed to join even after seven days if he/she communicates in writing to accept the appointment and in that case the official will be allowed to join after expiry of approved leave period. Controlling officers are advised to contact such successful candidates who are on leave for obtaining their consent to join after expiry of leave in writing. Similarly, candidates who do not wish to join may be encouraged to communicate the some in writing. The Regional/Divisional Heads are requested to obtain the declaration of those candidates who are declining the selection as Postman / Mail Guard, if any on or before 09-09-2023 as per the proforma already circulated.
- **14.** The Divisional / Unit heads are also requested to ensure timely issuance of appointment letters so that candidates can join their respective offices of posting at the earliest. The guidelines issued vide Directorate letter No. W-04/2/2020-SPN-I-Part(1) dated 19-10-2020 may be taken into consideration while issuing appointment orders. While issuing the appointment order, the term "APPOINTMENT" only to be used. The term "PROMOTION" Should NOT be used any-where in respect of these GDS candidates.
- **15.** Details of vacancies notified, filled and remained unfilled (category wise) may be intimated by **11-09-2023** for taking further action.
- **16.** Gradation list should be prepared at Divisional / unit level as per the guidelines on the subject.
