## Memo No. ADPS/CON/2-15/2023 Dated at Jammu, the, 30<sup>th</sup> August-2023

In pursuance of Postal Directorate letter No. A-34012/01/2023-DE dated 18.01.2023 and Circle Office Memo No. ADPS/CON/2-15/2023 dated 25-01-2023 & ADPS/CON/2-70/2023 dated 25-01-2023 & Memo No. ADPS/CON/2-15/2023 dated 20.06.2023, the notification for Limited Departmental Competitive Examination/Competitive Examination for promotion/direct recruitment to the cadre of Postal Assistant/ Sorting Assistant from eligible Postman/MTS/GDS for the vacancy year 2023 was issued.

2. The category wise and unit wise vacancies are as under: -

3. As per schedule announced, the examination for Paper-I & Paper-II was conducted on 12-03-2023 and Paper-III (Typing Test) was conducted on 25-06-2023 at three centers i.e. one each at Jammu, Srinagar & Leh.

4. As per Postal Directorate letter No. 17-08/2018-SPB-I dated 10.05.2019 and letter No. 17-08/2018-SPN-I dated 19.12.2022, the category-wise minimum qualifying marks for Paper-I, Paper-II and Paper-III i.e. DEST (Typing Test) is as under: -

5. As per Postal Directorate letter No. 17-08/2018-SPB-I dated 10.05.2019, only such candidates who has qualified each Paper, viz. Paper-I, Paper-II and Paper-III has been considered for final selection and his/her merit has been drawn in order of marks secured in Paper-I only. Marks secured by candidate in Paper-II & Paper-III are only qualifying in nature and these marks have not been added to marks secured in Paper-I to decide merit.

6. Also, as per Recruitment Rules 2022 of PA/SA cadre, notified in GSR 459 (E) dated 17.06.2022, communicated vide Postal Directorate letter no. 04-05/2015-SPN-I dated

6.2022 and Postal Directorate instructions issued vide letter no. X-126/6/2021-SPN-II ated 31.12.2021, a single merit list at Circle level with the successful Category-A/Part-(A), Category-B/Part(B) and Category-C/Part(C) candidates of the above LDCE/Competitive Examination is prepared and the selected candidates have been allotted to the Divisions/Units as per merit (category wise, i.e. UR, SC, ST & PwD) vis a vis order of preferences exercised by the candidates subject to availability of vacancies in the Division/Unit.

7. For candidates with Benchmark Disability, instructions contained in DoP&T O.M No. 36012/1/2020-Estt. (Res-II) dated 17.05.2022 circulated vide Postal Directorate letter no. SC-12/9/2022-SCT-DOP dated 03.06.2022 has been scrupulously followed.

8. As per Directorate standing instructions, shortage in PA/SA cadre in Divisions/Units has also been taken into consideration while making allotment of successful candidates to the Divisions/units to avoid any large-scale staff imbalance in a particular unit/Division.

9. While preparing the result, where the marks obtained by the candidates in Paper-I are same, the inter-se rank/ merit has been decided as per instructions contained in Postal Directorate letter no. 04-08/2019-SPN-I dated 11-12-2020.

10. Now, the Competent Authority has been pleased to announce the result of candidates who had appeared in the said competitive examination as detailed below: -

10. Offer of appointment/promotion will be issued by the concerned Divisions/Units i.e. concerned appointing authority to the selected candidates giving 15 days time to candidate(s) to either accept or refuse the offer/order. If a candidate(s) does not give his/her acceptance or refusal within stipulated time it shall be deemed to have been refused and accordingly supplementary result will be declared and post be offered to next eligible available candidate. The provision of 'deemed refusal' shall be communicated to the candidate.

11. In case, it is subsequently found that any of the selected candidate (s) was not eligible to the take the examination under the extant rules or instructions on the subject or for any other reasons or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, his /her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion /appointment letter to be issued by the Divisions/Units.

12. The selected candidates should note that the selection to the post of Postal Assistant/ Sorting Assistant is provisional subject to satisfactory verification of credential like Date of Birth, Educational Qualification, and Caste Certificate etc. If later on at any stage it is noticed that any of these candidates are not eligible to take the examination, under the rules or instructions on the subject or if the result of the candidate is found not correct for any other reasons, his/her name will be deleted from the selection list.

13. Further in respect of selected reserved category SC/ST/PwD candidates, the Appointing Authority is required to obtain category certificate in the prescribed format as prescribed by Central Government of India and issue appointment orders only after the verification of category certificate and after the completion of other formalities as required under rules for all selected candidates.

14. Divisional/Unit Heads are requested to issue formal orders/appointment orders immediately and before giving appointment to the selected candidates, it may ensure that the selected candidates fulfill all required conditions of relevant Recruitment Rules. Also, the Divisional Heads are advised to recheck the prerequisite condition prescribed for candidates with reference to their recommendations made while forwarding the application forms.

15. The information related to Names of the candidates, their roll number and community have been shown on the basis of information furnished by the Heads of Division/Unit. The Heads of the Division/Units are requested that particular of successful candidate vi.z names, roll number, community and their eligibility are re-checked before issuing offer of appointment. If any discrepancy has been found the same shall be corrected and matter should be reported to this office.

16. The Provisional status of candidates have been decided/lifted in accordance with the reports received from concerned Divisional/Unit Head and in accordance with clarification received from Postal Directorate vide letter W-4/10/2023-SPN-I-DOP dated 01<sup>st</sup> August 2023. Divisional/Unit Heads shall note that candidates who were provisionally allowed in accordance this office letter no. 2-15/LGO/2023 dated 23.02.2023, their provisional bar has been lifted and their candidature have been found eligible in accordance with the clarification received from Postal Directorate letter no. W-4/10/2023-SPN-I-DOP dated 01<sup>st</sup> August 2023.

17. Before appointment, it should be ensured that, no disciplinary /vigilance case is pending or contemplated or punishment is current against the selected candidates. The candidate against whom any vigilance or disciplinary case is pending or those undergoing punishment should not be promoted/appointed. The particular of such candidate shall be reported to this office with full details immediately.
