In case, there are any mistakes in the details of candidates, the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the promoted / selected candidate was not eligible to take the examination/ selection under the existing rules/ instructions on the subject or for any other reasons or in case any mistake is found with regard to declaration of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject.

4. The result of all successful candidates is subject to fulfillment of eligibility criteria to be decided by the concerned Divisional Head and vigilance status of the candidates. The official/ candidate against whom vigilance or disciplinary case is pending/ those undergoing punishment should not be promoted and such cases should be referred back to this office as per directions of directorate's letter no. X-7/6/2022-SPN-II dated 17.05.2023.

5. Appointment of candidates for promotion and seniority of selected candidates is subject to outcome of OA No. 0291/304/2020, 0291/549/2020 pending before Hon'ble CAT and WP No. 2422/2021 pending before Hon'ble High Court, Jaipur.
