7. All the Divisional Heads are directed to submit the unwillingness/refusal (unconditional) of the candidates by 14.12.2023 by 16:00 hrs, positively. If any Division/Unit especially in which the candidate is presently working is failed to submit the refusal timely to Circle Office, they will be held responsible for that.
