2. 7. Also, the Divisional/Unit Heads are advised to recheck the pre-requisite conditions prescribed for candidates, with reference to their recommendations made while forwarding the application forms before appointment of selected candidates.

9. While issuing the appointment order, the term "**APPOINTMENT**" only to be used. The term "**PROMOTION**" Should NOT be used any-where in respect of these GDS candidates.

10. In case, if it is found subsequently that any of the promoted/selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidate's due to any unforeseen reason in accordance with the existing rules and instructions on the subject or orders of Hon'ble CAT/High Court, if any.

11. Before appointment, it should be ensured that, no disciplinary/vigilance case is pending or contemplated or punishment is current against the selected/allotted candidates. If any such case exists, the same should be referred to this office.

12. If any candidate is unwilling to accept appointment, he/she should submit his/her unconditional declination/unwillingness to the Divisional Head of allotted Division/Unit. The Divisional/Unit Head will send original copy of unwillingness/ declination along with attestation through concerned ROs so as to reach this office by **15.03.2024**.

13. All other terms & conditions/ instructions of this office memo of even No. dated 16.02.2024 & 05.03.2024 hold good and may be taken into consideration while issuing appointment order.

14. The inter se seniority of the above candidate may be fixed as per rules on the subject.

15. The concerned Regions are requested to ensure timely completion of recruitment formalities by adhering to the guidelines issued vide Directorate letter No. W-04/2/2020- SPN-I-Part(1) dated 19-10-2020.
