OFFICE MEMORANDUM

Subject: Appointment of successful candidates of Combined Graduate Level Examination, 2023 (CGLE-2023)- reg.

The undersigned is directed to refer to Directorate's communication no. X-07/7/2023-SPN-II-DOP dated 30.01.2024 vide which dossiers of candidates of Combined Graduate Level Examination, 2023 were sent to Postal Circles for appointment to the posts of Inspector Posts.

2. Para-9 of the said communication indicated the condition to which the appointment of selected candidates is subject to. The same is reproduced below: -

"The appointment is subject to the outcome of W.P. (C) No. 16593/2023 filed by Shubham Pal & Ors before Hon'ble High Court of Delhi. This should be clearly mentioned in the "Offer of Appointment" as well as "Appointment Order" after joining."

3. In this regard, it may be noted that the said Writ Petition (C) No. 16593/2023 filed by Shubham Pal & Ors. has been disposed of by the Single Bench of the Hon'ble High court of Delhi vide order pronounced on 16.02.2024. However, the petitioners by way of filing LPA No. 202/2024 have challenged the verdict dated 16.02.2024 before the Division Bench of the Hon'ble High Court of Delhi. The matter is sub-judice and next hearing is on 20.05.2024. In this context, communication received from Staff Selection Commission is attached.

4. Therefore, all the Inspector Posts of CGLE-2023 are hereby informed that their appointment is subject to the following condition: -

"The appointment would be subject to the outcome of LPA No. 202/2024 filed by Shubham Pal & Ors. before the Hon'ble High Court of Delhi against the verdict pronounced in the Writ Petition (C) No. 16593/2023 by the Single Bench of the Hon'ble Court."

5. Circles are requested to revise the appointment offer / order accordingly and convey the same in writing to all the candidates of CGLE-2023 selected for appointment as Inspector Posts, whether joined or yet to join.
