2. These allotment have been ordered based on the recommendation of the "Transfer and Placement Committee" of the Circle Office duly approved by the Competent Authority and instructions contained in Directorate letter no. X-12/3/20232-SPN-II dated 03-08-2023.

- 3. The above promotion have been made on the basis of details of the officials eligible for promotion and special reports submitted by the Divisions. The Divisional Heads will go through these orders and examine the details of the official's w.r.t. their eligibility for promotion including their names in service records and if any discrepancy is found, it should be propltly reported to the Circle without issuing any further orders. It should be ensured the no Vigilance / Disciplinary case is pending against the officials, while effecting the promotion.
- 4. In case any vigilance / disciplinary case of the type referred to in OM No.22011/2/86-Estt (A) dated 12-01-1988 of DoP&T circulated vide Directorate memo. No.25-19/88-SPG dated 4-05-1988 and subsequently revised vide DoP&T memo. No. 22022/4/91-Estt (A) dated 14-09-1992 circulated vide Directorate memo no.25-19/88-SPG dated 13-10-1992 is pending against the officials, he / she should not to be relieved for posting without obtaining specific orders from this office.
- It should also be ensured before ordering said promotions that SC/ST certificates of the officials being promoted against SC/ST vacancies are verified from the concerned sources and if discrepancy is found, it should be promptly intimated to this office without issuing any further orders.
- The Appointing Authority reserve the right either to modify or cancel the promotion, if any of the officials is found not eligible for the promotion from any angle. No separate notice will be issued whenever modification / revision / cancellation are ordered.
- 7. The Divisional Heads concerned will issue transfer / posting order within 10 days from the date of issue of this memo and also ensure the relieve of the officials to join or decline the new post within 20 days issue of posting order. If the officials do not join or decline within the stipulated time period, it will be deemed declination of the promotion.
- 8 (i). The promotion of above said officials will take effect from the date of which the officials actually join the post of LSG (PO) after the issue of posting orders by the Divisions. Relief of the above said officials to the promotional post wherever necessary should be ordered by the Heads of Division/Unit only after satisfying the above points.
- (ii) Divisional Heads will issue posting orders of all the above officials within 15 days but the officials debarred for promotion on account of refusal of their earlier promotion shall only be allowed to join in promoted post only after the elapse of the debarment period (noted against each official in 'Remarks' column of above table at para -01).
- 9. The officials promoted on regular basis are not entitled for any pay fixation if they already availed the benefit by virtue of financial up-gradation under TBOP/BCR/MACPS. They will continue to get their present stage in Pay Matrix/Pay Band/Grade Pay without any further fixation on promotion to LSG (PO) Cadre ordered in this memo. The officials, who are entitled for fixation of pay, will have the option to have their pay, fixed under FR-22 (1) (a) (1). This option should be exercised within one month from the date of promotion. Option once exercised is final.
- 10 (i). The declination, if any, will be disposed by the Appointing Authority concerned. In case any of the officials decline the promotion, no fresh offer of appointment on promotion shall be made for a period of one year from the date of refusal of promotion or till a next vacancy arises, whichever is later. On the eventual promotion to the higher grade, such Government servant will lose seniority vis-à-vis his

/ her juniors promoted to higher grade earlier. The Divisional Heads should send a consolidated report to Circle Office in time about the declined officials along with application of officials.

- (ii) If any official refuses the promotion, the Divisional Head concerned will send the refusal to Circle Office by 30-06-2024 and the refusal received after this date will not been entertained.
- 11. If any of the promoted officials refuses to accept the regular promotion before becoming entitled to a financial up-gradation, no financial up-gradation under MACP Shall be allowed as such he/she has not been stagnated due to lake of opportunities. If, however, financial up-gradation has been allowed due to stagnation and he/she subsequently refuses the promotion, it shall not be a ground to withdraw the financial up-gradation. He /She shall not be eligible for further financial up-gradation under MACPS, till he/she agrees to be considered for promotion again and the second and the next financial up-gradation shall also be deferred to the extent of period of debarment due to the refusal.
- 12. The divisional allotment is subject to change if there is any variation in the vacancies in any division.
