MINUTES OF THE CIRCLE RELAXATION COMMITTEE MEETING (CRC) HELD ON 20-11-2023 & 29-11-2023 AT BENGALURU FOR CONSIDERATION OF CASES FOR COMPASSIONATE APPOINTMENT OF DEPENDENTS OF DECEASED/MISSING DEPARTMENTAL OFFICIALS UNDER COMPASSIONATE GROUNDS IN RELAXATION OF RECURITMENT RULES FOR THE VACANCY YEAR 2022 OF KARNATAKA CIRCLE

In accordance with the instructions contained in Directorate's letter no. 17-1/2022-SPG-II dated 23-03-2022 & 24-03-2022 and 17-12/2022-SPG-II dated 20-01-2023, the Circle Relaxation Committee (CRC) constituted by the Competent Authority comprising of the following officers met on 20-11-2023 and continued on 29-11-2023 to consider the cases of dependents of deceased officials of the Department seeking appointment on compassionate grounds in relaxation of normal recruitment rules to the cadres of Postal Assistant/ Sorting Assistants, Postman/Mail Guard & Multi Tasking Staff in Karnataka Postal Circle. The cases which were received upto 31-01-2023 at the Divisional / Unit level have been taken into consideration by the Committee against the earmarked vacancies for compassionate appointment for the vacancy year 2022. The Committee considered a total of 131 eligible cases uploaded Online as backlog data entry and 2 cases offline, which included 53 cases referred to this Committee by earlier CRC held on 10-05-2022 and review CRC held on 03-01-2023.

2. Summary of last CRC meeting held on 10-05-2022 & review CRC held on 03-01-2023:

The previous Circle Relaxation Committee meeting for the vacancy year 2021 was held on 10-05-2022 and a review CRC was held on 03-01-2023. A total of 209 cases were placed before the Committees for examination, out of which 28 cases were 'Recommended' for appointment on compassionate grounds, 126 cases were 'Rejected', and 53 cases were 'referred to next CRC'.

3. Cases placed before present CRC: The cases have been examined / considered in accordance with the guidelines/consolidated instructions issued vide DoPT OM Nos. (i) 14014/6/14-Estt.(D) dated 09-10-1998, (ii) 14014/02/2012-Estt.(D) dated 16-01-2013, (iii) FAQ in DoPT OM No. 14014/02/2012-Estt.(D) dated 30-05-2013, Directorate's clarifications issued vide letter nos. 17-1/2022-SPG-II dated 20-07-2023, 24-44/2022-SPG-II dated 10-11-2023 and revised relative merit points issued vide (iv) Directorate letter no. 17-1/2022-SPG-II dated 23-03-2022 and Standard Operating Procedure issued vide (v) Directorate letter no. 17-1/2022-SPG-II dated 24-03-2022. The Committee has analysed each case based on the parameters prescribed in the above mentioned guidelines / consolidated instructions while determining the indigence of the applicants.

The points generated automatically by the Online Backlog data entry portal have been verified by the CRC with the data entry made in the Portal and also as per the revised relative merit points communicated vide Directorate's letter No. 17-1/2022-SPG-II dated 23-03-2022.

4. <u>Vacancy Position</u>: (i) Following is the vacancy position in different cadres in Group 'C' which was arrived @ 5% of the total vacancies under Direct Recruitment Quota meant for Compassionate Appointment for the vacancy year 2022 as per the Directorate orders on the subject and the CRC has considered the cases for Compassionate Appointment limited to the extent of vacancies earmarked.

- 4. (ii) As per the guidelines issued on the scheme for compassionate appointment circulated vide DoPT OM No. 14014/6/14-Estt(D) dated 09-10-1998 and 14014/02/2012-Estt(D) dated 16-01-2013, the Circle Relaxation Committee constituted for considering requests for appointment on compassionate grounds should limit its recommendation to appointment on compassionate grounds in deserving cases based on the availability of vacancy meant for appointment under compassionate grounds, within the ceiling of 5% of vacancies falling under Direct Recruitment Quota.
- 5. Recruitment Rules Applicable for the Vacancies: As per the existing Recruitment Rules for PA/SA cadre, the candidate should have passed Bachelor's Degree from a recognized University & Institute. Also, as per Recruitment Rules prevalent for Postman/Mail Guard, the educational qualification required is 12th Standard pass from a recognised Board, should have studied local language at least upto 10th Standard, possess knowledge of working on computer and possess a valid Driving License of two wheeler or Light Motor Vehicle. Further, as per Recruitment Rules of Multi Tasking Staff 2018, a candidate should be 10th pass from a recognised Board and should have studied local language at least upto 10th Standard.

7. Degree of indigence:

- a. The degree of indigence of each applicant has been arrived at as per the guidelines issued by Postal Directorate vide letter no. 17-1/2022-SPG-II dated 23-03-2022 subject to fulfillment of eligibility conditions as per Recruitment Rules.
- b. Directorate letter no. 37-4/2013-SPB-I/C dated 12.06.2013 read with DOPT OM no. 14014/2/2009-Estt (D) dated 11-12-2009 and 14014/02/2012-Estt. (D) dated 16-01-2013, if a Candidate requesting for compassionate appointment, does not fulfill the minimum educational qualification in exceptional circumstances can be restricted to MTS cadre and recruited as 'Trainee'.
- c. In case of appointment of a widow not fulfilling the required educational qualification, for the posts of Multi Tasking Staff there is a provision for relaxation of requirement of educational qualification by <u>Head of the Circle</u> subject to the condition that she can satisfactorily perform duties of the post with the help of some on job training. This was taken into consideration while examining such cases and recommended accordingly.
- d: The committee has recommended for Selection to the Posts according to the merit points secured by the applicants, subject to fulfillment of other eligibility conditions as discussed above. In respect of all attributes, the date of death has been considered as cut off date for the purpose of assessing the indigent condition of the Applicant under RMPS for Compassionate Appointment
- e. The cases more than five years old to be referred to Directorate are considered based on age of the case strictly from the date of death upto the date of application.
- f. In accordance with Directorate's instructions issued vide letter no. 17-1/2022-SPG-II dated 23-03-2022, in case two or more applicants get equal merit points under Relative Merit Point System (RMPS), preference is given to those cases in which amount of family pension is less. If the amount of family pension also remains equal then amount of terminal benefits is considered for giving preference in such cases.

8. Details of Cases Examined and Recommended / Rejected / Referred to Next CRC:

The complete list of all cases generated from Online Portal as <u>Annexure - II</u> was examined by the CRC.

(a) Recommended by CRC for appointment on Compassionate Grounds: Based on the revised Relative Merit Point System issued by Directorate vide letter no. 17-1/2022-SPG-II dated 23-03-2022, out of the 131 cases (point no. 6 above refers) placed before the CRC, the most deserving cases ie., the top 80 (Eighty) eligible Applicants who secured highest points have been recommended by the CRC for appointment on compassionate grounds. The CRC decided to recommend the appointment of the applicants who came up in the selection zone, depending upon their suitability/solely based on merit points secured to the extent of 5% Direct Recruitment vacancies reserved for compassionate appointment quota, also keeping in view of the eligibility criteria mentioned under prevalent Recruitment Rules of Postal Assistant/ Sorting Assistant, Postman/Mail Guard and Multi Tasking Staff subject to relaxations on age, educational qualifications as the case may be. The details of such cases are furnished as generated from Online Portal as Annexure - III. The allotment of cadre / posts to the CRC recommended applicants as generated by the Online Portal has been verified by the CRC for their correctness.

- (ii) As per consolidated instructions on the scheme for compassionate appointment communicated vide DoPT OM F.No. 14014/02/2012-Estt.(D) dated 16-01-2013, upper age limit could be relaxed wherever found necessary, by the HOC. Also, the belated requests/cases where the death of a Government Servant took place long back say five years or so, are required to be forwarded to Directorate for consideration/approval as per Directorate's letter. No. 17-1/2022-SPG-II dated 24-03-2022.
- (iii) Out of the top 80 applicants who secured highest points, 6 applicants do not meet the eligibility criteria for minimum educational qualification / not studied Kannada in SSLC which is required for appointment. The Committee in accordance with the instructions mentioned above decided to exercise the powers vested to relax the eligibility criteria for minimum educational qualification in respect of these six cases wherein the applicants do not possess minimum educational qualification in SSLC / not studied Kannada in SSLC and recommended them for MTS / MTS-Trainee Posts, subject to the approval of the Competent Authority / Directorate.
- a. Smt.M.Nalina, W/o Late Shri.Umesh H.L., Ex-Postman, Bengaluru West Division Recommended for MTS post.
- b. Smt.Rekha, W/o Late Shri.A.Sathianathan, Ex-Postman, Bengaluru East Division Recommended for MTS post.
- c. Smt.Rukmini.K, W/o Late Shri.M.S.Kumar, Ex MTS, PTC, Mysuru) Recommended for MTS post.
- d. Ms.K.N.Nikitha, D/o Late Shri.Nagendra K.S., Ex-Postman, Bengaluru South Division Recommended for MTS-Trainee post and referred to Directorate for approval.
- e. Shri.Hemadrisha.S, S/o Late Shri.B.Sripadaraju, Ex-Postman, Bengaluru South Division Recommended for MTS-Trainee post and referred to Directorate for approval.
- f. Ms.Sampreethi Prakash, D/o Late Shri.Prakash.M.K., Ex-IP, Haveri Division Recommended for MTS-Trainee post and referred to Directorate for approval.
- (iv) The Committee recommends that the Divisional Heads should ensure that all the applicants recommended for appointment on compassionate grounds are fulfilling the Educational and other qualifications prescribed for the Posts as per the relevant Recruitment Rules before issuing appointment orders. They shall issue appointment order only after verifying all the eligibility conditions/documents/certificates. The appointment based on the recommendations of the committee is subject to the condition that the approved candidate will maintain the dependent family members of the deceased Govt. servant and if at any time it is found that the said family members are being neglected or not being properly maintained by him/her, his/her appointment may be terminated.

(b) Rejected by CRC due to consideration of cases for third time and change of applicant / less indigency and Closure of cases:

(i) Out of the 131 cases, 6 cases which have been placed for third time before the CRC, were considered and 'REJECTED' by the CRC as per instructions contained under point no. 5 of Directorate's letter no. 17-1/2022-SPG-II dated 23-03-2022 and also because these cases did not fall under the top 80 cases selected based on the vacancy position in each cadre, due to less points and less indigence. While arriving at this decision, the committee also kept in view the instructions mentioned vide Postal Directorate letter 24-157/2013-SPB-1/c dated 04-04-2016.

Postal Directorate vide Para 3 (I) of letter no. 24-157/2013-SPB-1/c dated 04-04-2016 had mentioned that

"Appointment on compassionate grounds is intended to render immediate assistance to the family of a government servant who dies in harness or retires on invalidation on medical grounds leaving his/her family in financial crisis. Such appointment is restricted to 5% of direct recruitment vacancies. As number of cases for compassionate appointment is much more than the number of vacancies available for the purpose, the most deserving cases are only recommended for compassionate appointment. Para 3(ii) of Postal Directorate letter 24-157/2013-SPB-1/c dated 04-04-2016 also mentioned that "As per DOP&T instructions a case can be considered for compassionate appointment even where the death or retirement on medical grounds of a Government Servant took place long back, say five years or so. While considering such belated requests it was, however, to be related to the need for immediate assistance to the family of Government servant in order to relieve it from economic distress. The very fact that the family has been able to manage somehow all these years should normally be taken as adequate proof that the family had some dependable means of subsistence.

The details of applicants 'REJECTED' <u>due to consideration for the third time and change of applicant / less indigency</u> by CRC are mentioned as generated from Online Portal as <u>Annexure- V</u>.

- (ii) Also, two (2) cases which were already placed before previous CRC and referred to next CRC ie., for vacancy year 2022 have been treated as 'CLOSED' with the approval of the HOC. The details of these two cases are furnished below:
 - a. <u>Case of Shri.Mirjaismail.R, S/o Shri.Rajasab G.Tarafdar, Ex-MTS, RMS 'HB' Division Division</u>: As per clarifications issued by Directorate vide letter no. 24-44/2022-SPG-II dated 10-11-2023, the cases of dependent family members where the Govt. officials have retired on medical invalidation grounds after 19-05-2015 cannot be considered for compassionate appointment. The date of medical invalidation of the official is 04-03-2020. Hence, as per the above mentioned clarifications of Directorate, his application for compassionate appointment has been treated as CLOSED. The decision taken has been concurred by the CRC.

- b. Case of Smt.Jayashree.B, D/o Late Shri. B.Basavanagouda, Ex-MTS, SRO, Ballari, RMS 'HB' Division: As per FAQs issued by DoP&T vide OM no. 14014/02/2012-Estt.(D) dated 30-05-2013, 'a married daughter can be considered for compassionate appointment subject to the conditions that she was wholly dependent on the Government servant at the time of his/her death in harness or retirement on medical grounds. She must support other dependent members of the family.' The case of Smt.Jayashree.B, D/o Late Shri. B.Basavanagouda, Ex-MTS, SRO, Ballari, RMS 'HB' Division does not satisfy the eligibility conditions for consideration of a married daughter for appointment on compassionate grounds. Hence, her application for compassionate appointment has been treated as 'CLOSED'. The decision taken has been concurred by the CRC.
- (iii) Closure of compassionate appointment case due to demise of the applicant: The case of Smt.Lakshmi.L, D/o Late Shri.Lingaraju, Ex-LDC, O/o GM(PA&F), Bengaluru which was listed under Annexure-IV "List of Incomplete cases" during review CRC for vacancy year 2021 held on 03-01-2023 due to submission of incomplete documents by the applicant was also 'CLOSED' due to demise of the applicant on 13-08-2023. Any other dependent family member can apply afresh for the compassionate appointment as the case has not been placed till date before any previous CRCs for consideration.
- 9. <u>Cases referred to Directorate:</u> As per the rules on the subject, the cases which are more than five years old / where there is an earning member in the family / missing person case / applicants other than spouse who do not have minimum educational qualification or not studied Kannada in SSLC have to be referred to Directorate for consideration/further decision. Out of the 80 recommended cases, 'sixteen' such cases have been recommended and referred to Directorate by the CRC. The details of these cases are furnished as generated from Online Portal as Annexure VI.
- 10. <u>Referred to Next CRC cases</u>: The CRC has decided to refer 45 cases to 'Next CRC' due to paucity of vacancies in the eligible cadre. The details of such cases are furnished as generated from Online Portal as <u>Annexure IV.</u>
- 11. In accordance with instructions contained under para no. 6 and 8 of Directorate's letter no. 17-1/2022-SPG-II dated 24-03-2022, letters have been obtained from the applicants who have declined compassionate appointment / sought time for submission of application for compassionate appointment and also from the Divisional Heads where there is no response from the applicants.
- 12. The rules/principles of law laid down by the Hon'ble Courts in connection with considering appointments on compassionate grounds contained in the following judgements are also kept in view while considering cases for compassionate appointments:

- (i) The Hon'ble Apex Court in its judgement dated April 8, 1993 in the case of Auditor General of India and others Vs. G. Ananta Rajeswara Rao [(1994) 1 SSC 192] has held that appointment on grounds of descent clearly violates Article 16(2) of the constitution; but if the appointment is confined to the son or daughter or widow of the Government servant who died in harness and who needs immediate appointment on grounds of immediate need of assistance in the event of there being no other earning member in the family to supplement the loss of income from the bread winner to relieve the economic distress of the members of the family, it is unexceptionable.
- (ii) As per the Hon'ble Supreme Court Judgement dated May 4, 1994 in the case of Umesh Kumar Nagpal Vs State of Haryana and others [JT 1994 (3) SC 525] has laid down the following important principles in this regard:
 - (a) Only dependents of an employee dying in harness leaving his family in penury and without any means of livelihood can be appointed on compassionate grounds.
 - (b) The whole object of granting compassionate appointment is to enable the family to tide over the sudden crisis and to relieve the family of the deceased from financial condition of the family of the deceased or medically retired Government servant is legally impermissible.
 - (c) Offering compassionate appointment as a matter of course irrespective of financial condition of the family of the deceased or medically retired Government servant is legally impermissible.
 - (d) Compassionate Appointment cannot be granted after lapse of reasonable period and it is not a vested right which can be exercised at any time in future.
- (iii) The Hon'ble Apex court has held in its judgement dated February 28, 1995 in the case of Life Insurance Corporation of India Vs Mrs. Asha Ramchanda Ambekar and others [JT 1994(2) S.C.183] that the High Courts and Administrative Tribunals cannot give direction for appointment of a person on compassionate grounds but can merely direct consideration of the claim for such an appointment.
- (iv) The Hon'ble CAT, Jabalpur Bench order dated 17.03.2009 OA No. 708 of 2008 in the matter of Kamlesh Trivedi Vs. Union of India & others in its Judgement that "The family is not found to be in penury conditions and there were more indigent person than the applicant. Thus the Tribunal would not be justified to reverse these findings recorded after complete appreciation of factual aspect."
- (v) Order dated 19.04.2010 of Hon'ble CAT, Ahmadabad Bench in OA No. 179 of 2009 in the matter of Shri Brijesh Kumar D. Patel Vs. Union of India & Others in its Judgement that "when subsequent to the death of the bread earner, sufficient time has passed and bereaved family has maintained themselves, there can be no direction to the competent authority to consider the claim for compassionate appointment. This is factual finding and the Tribunal will not enter into merits of the same because whether the deceased left the family in penury and without any means of livelihood has to be decided by competent authority and the courts can not normally interfere. Compassionate appointment cannot be claimed by way of right or as heritable public office."

In the case of HSEB Vs. Krishna Devi [JT 2003 (3) SC 485] it was held by the Hon'ble (vi) Apex Court that compassionate appointment cannot be claimed as a matter of right and against the guidelines prescribed by the Government.

In the recent orders issued in one of the OAs by Hon'ble CAT dated 29-11-2022, it has (vii) been stated that, "If appointment is made at later stage, the same shall be against the object and purpose for which compassionate ground appointment is provided, as the whole object of granting compassionate appointment is to enable the family of the deceased Government servant to tide over the sudden crisis; compassionate appointment is not a source of recruitment."

The Hon'ble CAT, Bangalore Bench while issuing orders dated 06-04-2023 in another OA No. No. 492/2020 filed by Shri. Ramesh M. Yaragatti has stated that, "Grant of Compassionate appointment at this stage would, therefore, not be keeping in view the spirit of the scheme of Compassionate Appointment.... the whole object of granting compassionate employment is to enable the family to tide over the sudden crisis...Mere death of an employee in harness does not entitle his family to such source of livelihood. The Government or the public authority concerned has to examine the financial condition of the family of the deceased, and it is only if it is satisfied, that but for the provision of employment, the family will not be able to meet the crisis that a job is to be offered to the eligible member of the family."

- The CRC has also taken into consideration the guidelines issued by Postal 13. a. Directorate vide letter No.24-157/2013-SPB-1/c dated 04-04-2016.
 - As per Para 7 of the Directorate's letter No.17-4/2017-SPB-I/C dated 05-04b. 2018 and Para 11 in Annexure to letter No.17-1/2022-SPG-II dated 24-03-2022 recommendations of the CRC may be placed before the Chief Postmaster General for consideration. Also under para 13 it has been mentioned that, 'if there is even a single case recommended by CRC which needs approval of Directorate, the recommendations of Committee will not be implemented till final decision of Directorate is received'.
