As per aforesaid clarification and Notification of the examination, candidates who exercised limited number of preferences and could not be allotted to prefer Division / Unit due to non-availability of vacancies are not considered for other Division / Units.

5. 04 (Four) SC vacancies of GDS to PM-MG Examination quota are remained unfilled due to non allotment of candidates as candidate's preferences are exhausted. 


