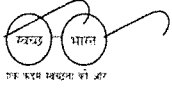

3. In OA no. 1174/2023 in which interim order was passed on 20.12.2023, where the applicant had challenged that despite of she submitting caste validity certificate her name was not included in the result declared in December 2022, resulted in an order to the effect that the recruitment

process/appointment initiated by the respondents vide the result shall be subject to the final outcome of the OA to the extent of adjustment of the applicant among the list of selected candidates as per merit and in her category.


