Subject: Proposal for creation of Rajnandgaon Postal Division by bifurcation of existing Durg Postal Division in Chhattisgarh Circle.

Sir

I am directed to refer to Chhattisgarh Circle letter No. Estt. 19/II/D.O. Durg dated 29.12.2023 on the subject mentioned above, and to say that the proposal for creation of new Rajnandgaon Postal Division by bifurcation of existing Durg Postal Division in Chhattisgarh Circle was examined in consultation with Integrated Finance Wing (IFW) of this Directorate. The proposal has been approved by the competent Authority subject to the following conditions:

- (a) Circle shall ensure that there is sufficient increase in revenue generation and accordingly fix targets for its improvement. Further, Circle shall evaluate the financial performance of the division, upon completion of one year. The financial review, along with ECR of Rajnandgaon Postal Division (with revenue & expenditure data of one year, before and after creation of the new division), duly concurred in by CIFA shall be submitted to Directorate for examination of IFW.
- (b) The recurring and non-recurring expenditure involved in creation of the division shall be kept to the minimum.
- (c) The redeployment of Group 'B' & 'C posts for the new Rajnandgaon Postal Division (ASPOs-1, Steno-1, Office Assistant-9, MTS-2), shall be done with the approval of competent authority', as per the extant instructions (redeployment of Group 'B' & 'C' posts within circle may be done by HoC in consultation with CIFA. Circle shall ensure that diversion of posts is not affecting the smooth flow of work in present establishments. Moreover, the posts to be re-deployed had neither been surrendered/recommended for abolition by any work study team/cadre review committee nor had been placed under "deemed abolished" category in terms of Deptt. of Expenditure guidelines
- 2. Further, the surplus post of PS Group 'B' of SP, PSD Kanpur, U.P. Circle is redeployed as Divisional Head of the newly created Rajnandgaon Postal Division.
- 3. In view of above, Circle is requested to take further necessary action in the matter and furnish an Action Taken Report to this office.

4. This sanction issues with the approval of competent authority. The advice of Integrated finance Wing was conveyed vide their Dy. no. 59/2024-25/FA-CS(P) dated 08.07.2024.
