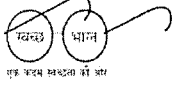

2. The Supplementary result is declared on the basis of reports of unfilled vacancy due to non joining of allotted candidates received from Regions/Divisions/Units and recommendation of concerned Regions/Divisions/Units heads. Total unfilled vacancies considered for the said result is enclosed herewith in Annexure III.

3. The result is prepared based on clarification given by Directorate vide letter No. 03-03/2019/SPN-I dated 19.06.2019 and Notification of the aforesaid examination. As per aforesaid clarification and Notification of the examination, candidates who exercised limited number of preferences and could not be allotted to prefer Division / Unit due to non-availability of vacancies are not considered for other Division / Units.


4. Total 11 UR vacancies of GDS to PM-MG Examination quota 2021 are remained unfilled due to non allotment of candidates as candidate's preferences are exhausted. These 11 UR vacancies are to be considered for further recruitment process as per Recruitment Rules. Details of unfilled vacancies due to non allotment in Annexure IV is enclosed herewith.

5. Further, it is observed that after declaration of result the joining formalities take so much time to complete due to which further process of filling up the vacancies is badly delayed. Hence, Regions / Divisions/Units are requested to complete all joining formalities within following time line: -

- i. Issue the offer of appointment letter by : - 26.07.2024
- ii. Inform the unfilled vacancies due to non-joining of candidates to Region – 29.07.2024
- iii. Consolidated report by Region to CO: - 31.07.2024
