G.S.R. In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of (i) Department of Posts, Accounts and Finance Service, Group 'B' (Senior Accounts Officer) Recruitment Rules, 2005 and (ii) Department of Telecommunications, Accounts and Finance Service Group "B" (Senior Accounts Officer) Recruitment Rules, 2000, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Senior Accounts Officer of Indian Posts and Telecommunications Accounts and Finance Service Group 'B'in the Department of Posts and Department of Telecommunications under Ministry of Communications, namely:—

- 1. Short title and commencement: (1) These rules may be called Indian Posts and Telecommunications Accounts and Finance Service Group 'B', (Senior Accounts Officer) Recruitment Rules, 2024.
- (2). They shall come into force on the date of their publication in the Official Gazette.
- **2. Application**: Theses rules shall apply to the post specified in column (1) of the Schedule annexed to these rules.
- 3. Number of posts, classifications and pay level in pay matrix: The number of said posts, their classification and level in pay matrix attached thereto shall be as specified in column (2) to (4) of the Schedule annexed to these rules.
- 4. Method of recruitment, age limit and other qualifications, etc: The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
- 5. **Initial constitution:** The personnel holding the posts on regular basis, before the commencement of these rules, shall be deemed to have been appointed in accordance with the provisions of these rules.
- **6. Liability for transfers:** Persons appointed to the said posts shall be liable to transfer anywhere in India.
- 7. **Disqualification:** No person, -
- (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible, under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

8. Power to relax: Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing and in consultation

with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

9. Saving: Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex- servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
